- 2024 CX
  - Indianapolis and St. Louis locations being reviewed
  - o Carl, Angela, Amber and Katy met with the CVBs in both cities
  - Looking at 2 sets of dates: May 31 June 5, or June 7 12
  - o Indianapolis
    - More affordable options
    - Greater hotel availability for May 31 June 5
    - 6 RFP responses
    - Room rates range from \$179/nt (Alexander/Hyatt Place) to \$259/nt (Conrad)
    - \$10k \$25k food and beverage minimums
    - Room rentals waived for all if F&B met
  - St. Louis
    - 8 RFP responses
      - Only 5 have availability for our dates
    - Room rates from \$189/nt (Hyatt Regency) to \$249/nt (Marriott Grand)
    - Room rentals waived for all if F&B met
    - \$15k \$25k food and beverage minimums
    - Open to some concessions
  - Scott made a motion for Central CX 2024 to take place in Indianapolis with dates of May 31 – June 5
    - Kim 2<sup>nd</sup> motion
    - All in favor Motion passed
